The successful candidate will be fundamental to the success of this programme and will contribute to the legacy of Imagine Rotherham.

They will be able to demonstrate knowledge of issues currently facing schools and other educational settings. The postholder will communicate our vision in a warm, approachable, and friendly manner, possessing excellent interpersonal skills and an ability to build strong professional relationships with key stakeholders.







## Job Description

#### Purpose of the Post

The Creative Programme Manager will work with Imagine Rotherham to:

- Embed arts and creativity into formal education in Rotherham
- Excite, inspire and delight all children and young people with engaging and creative programmes
- Develop an inclusive, high quality and creative workforce that can confidently embed creative approaches to teaching in their practice

### Main Areas of Responsibility

The Creative Programme Manager will:

- Design and manage professional development and mentoring for both educationalists and creative practitioners, which will enable them to develop inspiring creative experiences and opportunities for children and young people in Rotherham
- Embed creative approaches long-term by identifying suitable grants and funding opportunities to ensure the sustainability of the LCEP and the role of Creative Programme Manager
- Grow local talent from the creative and cultural sector, bringing people together from a diverse range of backgrounds and lived experiences, ensuring children and young people see themselves reflected in the adults that work with them
- Provide opportunities that are accessible to all children and young people in primary, secondary, special and alternative provision
- Develop a creative curriculum which makes use of and celebrates the culture and history of the local area
- Develop delivery of Artsmark and Arts Award in formal education, supporting more schools and creative practitioners to formally connect with the programmes and existing networks
- Develop our website, making good use of connections with JMAT and Forge CPD to do this. The website is supported by RoSIS and Learn Sheffield, and offers resources and guidance on 'igniting excellence in education'.
- Continue to develop the creatives education network that enables practice sharing and support from peers. This includes creative teach meets, where both teachers and creative practitioners can meet, share practice, resources, and approaches.
- Monitor and respond to data that tells the story of our impact, and evaluate the progress alongside the vision
